## Notice of Race

The Organizing Authority (OA) is the Long Beach Yacht Club (LBYC). LBYC is located at 6201 Appian Way, Long Beach CA 90803. Phone number is (562) 598-9401. Club and Event information are available at [www.lbyc.org](http://www.lbyc.org).

### 1 RULES

- 1.1 This regatta will be governed by the "rules" as defined in the 2013-2016 *Racing Rules of Sailing* (RRS), and the Cal 25 National Rules & Specifications Version 3.4.1.
- 1.2 Competitors are reminded that under the preamble of Part 2 of the RRS boats racing must comply with Rule 9 of the Inland Navigation Rules (72 COLREGS) when they meet other marine traffic.
- 1.3 In the event there is a conflict between the Notice of Race (NOR) and the Sailing Instructions (SI), the SI shall prevail. **This changes RRS 63.7**
- 1.4 **US Sailing Prescription Appendix T Sections A, B and C shall be in effect.**
- 1.5 All boats shall be in the water no later than August 12, 2015 at 1800 hours and remain in the water until racing is over, unless granted permission by the OA.

### 2. ADVERTISING

- 2.1 This regatta shall be held in compliance with ISAF Regulation 20. The OA may require event advertising to be placed on boats.

### 3 ELIGIBILITY AND ENTRY

- 3.1 The regatta is open to all competitors meeting the current Cal 25 National Rules and specifications as posted on the Cal 25 website. Skippers shall be a registered owner and member of the Cal 25 Class and affiliated Cal 25 Fleets.
- 3.2 Yachts may be subject to inspection by the Fleet V Measurer or Executive Board prior to the regatta. Resolution of any eligibility or boat measurement issues shall be the responsibility of the Cal 25 Fleet V executive board. Measurement deadline is August 14, 2015 at 1800 Hours.
- 3.3 A minimum of six (6) entries are required to constitute a regatta. If six (6) paid entries are not received by August 12, 2015, the regatta will be cancelled.
- 3.4 **ENTRY FEE \$100** All checks shall be made payable to "Cal 25 Fleet V". Entries shall be submitted to Long Beach Yacht Club, 6201 E. Appian Way, Long Beach, CA 90803, in person or mailed with "Attention: Cal 25 Nationals" written on the envelope, no later than August 12, 2015.

## **7 THE COURSES**

Courses will be windward/leeward courses.

## **8 RADIO COMMUNICATIONS**

While on the water, the RC intends to communicate with competitors via VHF radio for course information and OCS starting penalties.

## **9 PENALTY SYSTEM**

9.1 US Sailing Prescription Appendix T Sections A and B shall be in effect.

## **10 SCORING**

10.1 The Low Point System of RRS Appendix A will apply, except that each boat's total score will be the sum of her scores for all races completed. **This changes Rule A2.**

10.2 Up to Seven (7) races are scheduled; three (3) races must be completed to constitute a regatta.

## **11 PRIZES**

11.1 Trophy presentation will be as soon as possible after racing on Sunday, August 16 at LBYC.

11.2 The Cal 25 National Championship Perpetual Trophy will be awarded to the winning skipper.

11.3 Take home trophies will be awarded based on the number of entries.
